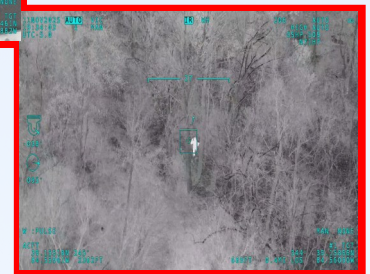
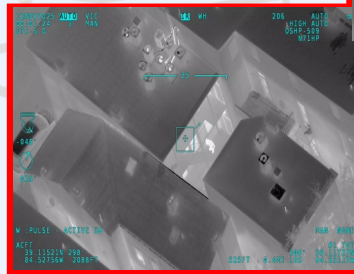
## OPERATIONS

### Cincinnati Proactive Patrols and Media Interview

Aviation participated in multiple proactive patrol details in the month of November. Working with the Cincinnati Police Department and multiple District 8 patrol posts, Aviation provided aerial support as ground units conducted traffic stops and responded to calls for service. The statistics from the details are as follows:

- 3 Suspects Apprehended with Air Assistance
- 1 Vehicle Pursuit
- 1 Foot Pursuit
- 5 Felony Drug Cases Generated
- 1 Felony Warrant Service
- 1 Seized Firearm
- 1 Stolen Vehicle Recovered

### OPERATIONS

#### Dayton Proactive Patrols

Throughout November, Aviation supported the Dayton Police Department and the Dayton Patrol Post during proactive patrol details. The Aviation Unit provided aerial coverage while ground units conducted traffic stops, responded to calls for service, and saturated areas known for higher or violent crime. The statistics from these details are as follows:

- 8 Suspects Apprehended with Air Assistance
- 3 Vehicle Pursuit
- 2 Foot Pursuits
- 3 Felony Drug Case Generated
- 9 Warrant Services (2 Misdemeanor, 7 Felony)
- 3 Firearms Seized
- 2 Stolen Vehicles Recovered



#### Canfield Post Photo Flight

Aviation received a request on November 22 from the Canfield Patrol Post to take aerial photos of an apartment building in Austintown Township, Mahoning County, where an explosion caused injuries and major damage. Aviation responded, forwarding the photo officers to continue their investigation.

### OPERATIONS

#### Medina Post Pursuit



On November 6, Aviation monitored local post radio traffic and was alerted to a pursuit involving Medina Patrol Post units traveling southbound on I-71 north of Brunswick. Aviation self-initiated a response from the Akron Fulton Airport and proceeded toward the pursuit area. The suspect vehicle had initially stopped for a speed violation before fleeing. As the pursuit continued south on I-71, the Medina County Sheriff's Office successfully deployed spike strips, deflating one of the vehicle's tires. The vehicle turned around near State Route 83 in Lodi and traveled northbound on I-71 before pulling off onto the right berm and grass area, where both occupants fled on foot. Ground units located the female passenger in a small, wooded area near the abandoned vehicle. Aviation located the male suspect in a field near a farm southeast of the vehicle. Both individuals were taken into custody without further incident. It was later determined that the male driver did not possess a valid license and had active misdemeanor warrants.

#### Cleveland Proactive Patrol

Aviation responded to a request from the Cleveland Police Department and Cleveland Patrol Post on November 6, to assist with a proactive enforcement detail targeting criminal activity in the City of Cleveland. While overhead, the flight crew supported two vehicle pursuits that resulted in the apprehension of both drivers. At least two firearms were recovered during these incidents. Additionally, Aviation assisted Cleveland Police with a call for service involving a vehicle connected to an aggravated robbery. The vehicle was located, and four individuals were observed fleeing into an apartment complex. All four suspects were taken into custody without further incident.



#### Bowling Green Post Photo Flight



On November 14, Aviation responded to a request from the Bowling Green Patrol Post to obtain aerial photos of a plane crash in Henry County that resulted in two fatalities. Aviation captured video and photos of the scene and surrounding area, forwarding the evidence to the investigating units.

### OPERATIONS

#### Montgomery County Criminal Search

On November 17, Aviation assisted the Montgomery County Sheriff's Office and the U.S. Marshals in apprehending a fugitive wanted on multiple felony warrants, including aggravated robbery, weapons under disability, tampering with evidence, and obstructing official business. Detectives located the suspect in a vehicle parked in a lot. With aerial support overhead, officers approached, and when the suspect attempted to flee, patrol cars boxed him in, preventing escape. Officers then took the suspect into custody without incident.



#### Toledo Proactive Patrol

Aviation responded to a request from the Toledo Patrol Post and Toledo Police Department on November 14, for a proactive enforcement detail targeting criminal activity in the City of Toledo. While overhead, Aviation assisted with a pursuit involving two minibikes, one of which crashed. Aviation guided ground units to the fleeing subject, and officers took the 15-year-old suspect into custody without incident. Aviation also relayed information on vehicles operating recklessly on I-75. One suspect vehicle was stopped, and the driver issued a summons, while another continued onto I-280 before stopping at a residence, where officers issued a summons. Aviation monitored areas of concern for street racing and supported traffic stops before being released upon completion of the detail.



#### SOFAST Jefferson County ISR Flight

Aviation responded to a request on November 28 from the Columbus Police Department to assist the Southern Ohio Fugitive Apprehension Strike Team with surveillance of a residence, for a future warrant service. Aviation captured video of the residence and all associated vehicles as requested. The flight crew coordinated with task force units to forward evidence, to continue their investigation.
